Policies

Membership Policy

Membership at Fort William Golf & Country Club is **continuous** until such time as the member provides notice of resignation in writing, or such time when the member no longer meets the eligibility requirements of the membership.

The applicant agrees to allow Fort William Golf & Country Club use of their personal information provided above solely for purposes related to the normal administration of the club, per our Privacy Policy.

The Fort William Golf and Country Club will charge the credit card on file for payment of the applicant's Membership dues, additional services and Capital Improvement fees and monthly House Account charges unless otherwise advised.

Membership is confirmed when the application is processed and the member receives a confirmation email.

****Note:** We require up to 2 business days to process applications after April 20th.

House Account Policy

House accounts are created for all membership categories with the exception of Junior memberships.

House account payments will be processed monthly; and if a Member's Monthly House Account credit limit is exceeded before the next payment due date, the credit card on file will be charged the outstanding balance immediately.

Members with unpaid balances beyond 2 payment cycles may have their Club privileges suspended.

Membership Refund / Cancellation Policy

Requests received prior to May 1st will receive a full refund.

Requests received before July 15th will receive a 50% refund to be applied against a renewal of the next season's membership fee. *(Request must be accompanied by a Medical Certificate)*

For requests received as of July 15th, no refund will be issued. Member can make a request directly to the Board of Directors.

Fall promotion memberships cancelled prior to the beginning of the golf season will lose the 50% Fall payment, up to a maximum of \$1000.

All refunds are subject to a \$40.00 administration fee.
